

## **Queen's Students' Union - SU Elections 2024**

### **Terms & Conditions**

#### **£1 Pint in the Union Bar – Open to All Students**

1. The competition is open from 10am, Monday 4 March, 2024  
The closing date for receipt of entries is 3pm, Thursday 7 March, 2024
2. If 5,500 overall votes are cast in the SU Elections by the closing date and time (3pm, Thursday 7 March, 2024), a 1 x £1 Pint of Carling Larger OR 1 x £1 Pint of Carling Apple Cider (or non-alcoholic option from the drinks 'gun') will be available for purchase in the Union Bar between 4-5pm on Thursday 7 March. This offer excludes: Carling Black Fruits Cider.
3. The hour time slot as to when this offer will be available, as well as the alcoholic and non-alcoholic options included in this offer will be promoted via an all-student mailer and QSU social pages on Wed & Thurs 6 & 7 March
4. Access to the Union Bar during the offer period is dependent upon the Union Bar's capacity which is subject to health and safety regulations.
5. To cast their vote entrants must visit <http://www.q-su.org/> and vote in the SU Elections 2024, held from 10am, 4 March 2024 – 3pm, 7 March 2024
6. Solely voting in the Clubs & Societies Committee Elections does NOT constitute voting in the SU Elections
7. The offer can only be availed of on presentation of a valid QUB student card and the participating student's hand will be stamped upon purchase in line with the offer and to limit consumption within the timeframe of the promotion.
8. Entrants must: be over the age of eighteen on the closing date and be a current member of Queen's Students' Union (St Mary's and Stranmillis students are not eligible). Queen's Students' Union reserves the right to request proof of age and sight of a valid Queen's University student card.
9. Entries from third parties or agents or incomplete entries will not be accepted. All entries must be made directly by the person entering the promotion.
